LoLa 2013 Participation Guidelines, Fees & Registration

Please note: registration and fee structure has been expanded for LoLa 2013.

There are now 3 categories of participation which require registration:

I. Individual Artist Registration

Deadline May 1, 2013

2. Site Registration Deadline June 1, 2013

3. LoLa Community **Sponsorship** Deadline July 1, 2013

Each registered artist and site will receive a confirmation letter and LoLa 2013 Welcome Packet containing additional important information, artist volunteer opportunities and dates to remember.

I. Individual Artist Registration

Participation in LoLa is limited to artists living/working in the greater Longfellow neighborhoods

(the geographic area defined as east of Cedar Avenue to the Mississippi River, and south of 28th Street to the Crosstown).

To participate in LoLa 2013, each & every artist must be eligible, registered & pay \$25 fee.

Artists and sites not adhering to this requirement may find themselves restricted from future LoLa art crawls.

Working in the defined neighborhood is defined as being employed by a business in the neighborhood (simply exhibiting in a local business is not sufficient).

The reason for these restrictions is that LoLa is not just another summer art fair.

LoLa is committed to raising the visibility of local artists in this neighborhood and to building a true sense of community for these artists.

Artists' active participation in promoting and facilitating the work of the art crawl is an expectation of registration.

What the Artist Registration fee covers:

- The cost of printing of advance cards, posters, maps
- Each artist will be listed on the LoLa website with a description of their art work and a link to their own website;

2. Site Registration (new this year)

To participate in LoLa 2013, each and every site must be registered.

There is no fee to register to be a LoLa 2013 site.

Each site is asked to send in a separate check for \$15 as a deposit for a site sign. The deposit will be returned after the art crawl when the sign is returned.



This year each sign will:

- be numbered,
- delivered to the sites.
- picked up at the end of the crawl.

If you are an artist planning to exhibit at your own site, please complete both an artist registration form and a site registration form.

If you are not sure where you will exhibit,

indicate that on the artist form. You will be contacted by a LoLa volunteer to match you with an appropriate business host or other exhibiting artist.

If you are a business wishing to host artists,

please complete a site registration form. You will be contacted by a LoLa volunteer to confirm the specific requirements of your space.
